The financial incentives to blocks will also be given on a quarterly basis. States are also requested to provide suitable incentives to high-performing blocks so that the process remains competitive. Blocks are the key second-tier local governance which was created postindependence in the 1950s. There are about 7,000 blocks across the states in India. In consultation with various stakeholders including states, 39 key performance indicators (KPIs) have been chosen to measure the progress of the blocks which have been grouped into five themes. The themes include health and nutrition, education, agriculture and allied services, basic infrastructure and social development. The soft launch of ABP happened on January 7. "Around 5,000 people or ten people in each of the 500 blocks have trained for the ABP programme,"the official said. Out of the 500 ABP blocks, the Cabinet will also soon consider a Particu-

(PVTB) scheme for 60 tribal blocks under a special development drive. "The Expenditure Finance Committee (chaired by the Expenditure Secretary) has already vetted the proposed PVTB scheme," the official added. By March, just ahead of the general elections in April-May, some concrete achievement in various indicators is expected. "In three years, the aspirations blocks are expected to reach the state-level average for blocks in various parameters," the official said, stressing that Prime Minister Narendra Modi will be closely monitoring the progress through Niti Aayog.

Another major concern is the resolution of terms of payment of the \$1.2-billion term loan B (TLB), which Byju's had raised in November 2021 with a five-year tenure, but the lenders have revised the terms of the loan wanting earlier payment. FE had recently reported that Byju's will see its interest outgo on the \$1.2-billion term loan further rising because Fidelity Advisor, one of the lenders in the consortium, has almost doubled the rate to 15.5% in a year's time, according to its filing with the Securities and Exchange Commission. Fidelity Advisor was charging 7.01% in July 2022 and had subsequently raised it

to 10.7% in January this year. Byju's had come under scrutiny from the ministry of corporate affairs for filing its FY21 results also 18 months beyond the prescribed timeline. It had reported a net loss of ₹4,588 crore from ₹231.69 crore in FY20. The company's total revenues during the year sawa marginal decline of 3.32% to ₹2,428.39 crore. The huge jump in losses during the year was due to the deferral of 40% of revenues to subsequent years, but costs not getting deferred Currently, former State Bank of India chairman Rajnish Kumar and ex-Infosys CFO, TV Mohandas Pai are on Byju's advisory council. They joined the council on July 13 to advise the firm on the composition of its board and governance structure. The edtech firm recently vacated its largest office space in Bengaluru to cut costs. It's also exploring sale of two of its assetsupskilling platform Great Learning and California-based reading platform, Epic—to generate around \$800 million to \$1 billion to repay the \$1.2-billion term loan in the next six months. The company is also in talks with Abu Dhabi Investment Authority to raise fresh capital. Its new CEO Arjun Mohan is in the process of restructuring the company's businesses, including cutting the headcount by 4,000-4,500



# जयपुर में युवक की पिटाई से मौत के बाद तनाव

जयपुर, 30 सितंबर (एजंसी)।

राजस्थान की राजधानी जयपुर के रामगंज और आसपास के इलाकों में शनिवार को तब सांप्रदायिक तनाव पैदा हो गया जब दो मोटरसाइकिल के बीच टक्कर के बाद कुछ लोगों द्वारा कथित तौर पर पिटाई के कारण एक युवक की मौत हो गई। पुलिस ने यह जानकारी दी।



दिन प्रतिदिन के घरेलू कामकाज समेत छोटी-छोटी अन्य आकस्मिक गतिविधियों से दिल का दौरा, 'स्ट्रोक' और यहां तक कि समय से पहले मौत का खतरा भी कम हो जाता है।'द लांसेट पब्लिक हेल्थ' के शोध के आधार पर यह दावा किया गया है। हालांकि, दैनिक गतिविधि की अवधि और तीवृता भी मायने रखती है।

सिडनी विश्वविद्यालय के नेतृत्व में ब्रिटेन और आस्ट्रेलिया की शोध टीम ने अध्ययन के दौरान लगभग आठ साल तक ब्रिटेन के 25.000 से अधिक वयस्कों पर नजर रखी। अध्ययन के वरिष्ठ लेखक इमैनुअल स्टैमाटाकिस (सिडनी विश्वविद्यालय) ने कहा, 'सीढ़ियां चढ़ने से लेकर तेजी से फर्श साफ करने तक, हाल के वर्षों में हम यह समझे हैं कि यह केवल संरचनात्मक व्यायाम नहीं है जो हमारे स्वास्थ्य के लिए अच्छा सिडनी विश्वविद्यालय के नेतृत्व में ब्रिटेन और आस्ट्रेलिया की शोध टीम ने अध्ययन के दौरान लगभग आट साल तक ब्रिटेन के 25,000 से अधिक वयस्कों पर नजर रखी।

है, बल्कि हम इस बारे में बहुत कम जानते हैं कि छोटी-छोटी अवधि की आकस्मिक गतिविधि हमें कैसे स्वास्थ्य लाभ पहंचाती है।

अध्ययन में शामिल वयस्कों की उम्र 42-78 वर्ष थी, जिनमें से सभी ने स्वयं बताया कि उन्होंने व्यायाम या खेल में कोई भागीदारी नहीं की है। शोधकर्ताओं ने ब्रिटिश 'बायोबैंक' और 'मशीन लर्निंग' से डेटा का उपयोग किया और उनकी सात-दिवसीय आकरिमक शारीरिक गतिविधि के 'पैटर्न' का विश्लेषण किया जिसमें 10 सेकंड तक की गतिविधि को भी शामिल किया गया। इसके बाद उन्होंने इन शारीरिक गतिविधि के सूक्ष्म पैटर्न की प्रतिभागियों के स्वास्थ्य रिकार्ड से तुलना की। इसके लिए उन्होंने प्रतिभगियों पर आठ साल तक नजर रखी ताकि यह समझ सकें कि छोटी-छोटी शारीरिक गतिविधियों की अविध और तीव्रता का स्वास्थ्य पर क्या असर पडता है।

शोधकर्ताओं ने पाया कि परे दिन की करीब सभी शारीरिक गतिविधि (97 फीसद) कई 'स्लाट' (टुकड़े) के रूप में संचित थी जिनमें से हर स्लाट 10 मिनट से छोटा था। सिडनी में 'पोस्टडाक्टोरल रिसर्च फेलो' मैथ्यू अहमदी ने कहा, 'दैनिक जीवन की गतिविधियों के माध्यम से मध्यम से मजबृत गतिविधि की छोटी-छोटी अवधि सुनिश्चित करने का विचार शारीरिक गतिविधि को उन लोगों के लिए अधिक सुलभ बनाता है जो संरचनात्मक व्यायाम में भाग लेने के इच्छुक या असमर्थ हैं।' लेकिन उन्होंने कहा कि इन गतिविधियों की अवधि और तीव्रता भी मायने रखती है।
